PRELIMINARY DRAFT - NOT READY FOR INTRODUCTION

AN ACT to amend 71.08 (1) (intro.) and 71.10 (4) (i); and to create 20.835 (2) (cc) 1 $\mathbf{2}$ and 71.07 (8n) of the statutes; relating to: creating an individual income tax 3 credit for certain expenses incurred by an emergency responder.

Analysis by the Legislative Reference Bureau

This bill creates a refundable individual income tax credit for volunteer emergency responders for unreimbursed expenses for gear and equipment purchased by the claimant for his or her use while serving as an emergency responder. The bill defines emergency responder as a volunteer first responder, fire fighter, or emergency medical technician. The credit may also be claimed by such an individual for his or her mileage costs to drive in his or her personal vehicle to attend training necessary to the claimant's service as an emergency responder. The maximum credit that a claimant may claim each year is \$400. The credit may not be claimed by nonresidents or part-year residents of this state. Because the credit is refundable, if the amount of the credit for which the claimant is eligible exceeds his or her tax liability, the difference will be refunded to the claimant by check.
