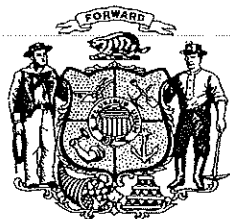


The following is the preliminary General Fund cash forecast for the three months from July 2023 – September 2023.
