Dear Senator Marklein and Representative Born:

Enclosed, please find the 2023 Entitlements and Recommended CY 2024 Payments under the Municipal Services Payments (MSP) Program, as required under s. 70.119.

The Department submits this payment summary report for municipal services provided during calendar year 2022 as required under s. 70.119(6). The report shows the entitlements as derived by applying the MSP Program formula, program adjustments and the prorated payments calculated by the Department of Administration, as required by s. 70.119, Wisconsin Statutes.

The number of towns, villages, and cities eligible for payment is 364. The recommended payments are at 38.18 percent (38.18%) of the total adjusted gross entitlements (\$48,680,769.04). The reduction is necessary to contain the program within its \$18,584,200 appropriation. The reduction of payments on a pro-rata basis is a standard action required by s. 70.119(7)(a) whenever the appropriation is insufficient.
