

HIGHLIGHTS OF COMMERCE AND INDUSTRY IN WISCONSIN

Manufacturing — Value added by manufacture in Wisconsin totaled \$67 billion in 2008, an increase of \$1.3 billion since 2004. The industry groups with the highest value added in 2008 were food, \$10.2 billion; machinery, \$8.5 billion; fabricated metal products, \$7.7 billion; and paper, \$6 billion.

Wisconsin ranked 10th among the states in value added by manufacture in 2008. Leaders in this category were California, \$250 billion; Texas, \$192.8 billion; and Ohio, \$121.8 billion. The national total for value added was \$2.266 trillion in 2008, an increase of \$241 billion since 2004.

Energy Consumption — In 2009, Wisconsin's total energy use per capita reached 297.3 million Btu, 2.3% higher than the usage rate in 1990 and 14.8% higher than in 1970. Seen from a national perspective, Wisconsin has gone from consuming energy at about 85% of the U.S. average in 1970 to about 1% more than the national average in 2009. Compared to various national averages, Wisconsin places a much heavier reliance on coal for its energy usage, but uses less petroleum, natural gas, nuclear power, and renewable energy. As energy consumption has increased, Wisconsin, which was an exporter of electricity in the 1970s, has increasingly become a net importer. Of the petroleum consumed in Wisconsin in 2009, the largest portion, about 81.4%, was used for transportation, followed by residential (7.6%), agricultural (4.6%), and industrial (3.3%) usage.

Gasoline Usage and Tax — In 2008, each automobile in Wisconsin was driven an average of 13,805 miles. This is 2,017 miles, or about 17%, more than the national average of 11,788 miles per year. Wisconsin automobiles averaged 22.7 miles per gallon of gasoline, nearly the same as the national average of 22.6 mpg. These mileage and fuel economy statistics pertain to standard passenger cars and do not include data for minivans, pickup trucks, or sport utility vehicles.

The state motor fuel tax was indexed annually prior to April 1, 2006. Since indexing began on April 1, 1985, the average annual adjustment in state tax was typically between 0.4 and 0.8 cents. After April 1, 2006, the state motor fuel tax can only be changed by legislative action. The current tax has not increased since then, when it was indexed to a total of 30.9 cents per gallon. The federal government's gasoline tax has also remained at 18.4 cents per gallon since that date, for a total of 49.3 cents per gallon in federal and state taxes.

Exports and Markets — In 2010, Wisconsin's leading exports were industrial machinery, including computers, \$6.3 billion; electric machinery, \$2.6 billion; and scientific and medical instruments, \$2.1 billion. The leading market for Wisconsin exports in 2010 was Canada (\$6 billion), followed by Mexico (\$2 billion), and China (\$1.3 billion). The total of all exports from Wisconsin to all markets in 2010 was \$19.8 billion.

Financial Institutions — The number of banks operating in Wisconsin has decreased from the post-Depression high of 647 in 1982 to 299 in 2010. Over the same period, deposits increased from \$22.5 billion to \$126.7 billion. In 2010, Wisconsin's 34 state and federally chartered savings institutions had total deposits of \$15.1 billion.

In 2010, Wisconsin had 223 state-chartered credit unions with over 2.1 million members and \$20.7 billion in assets.

Corporations — In 2010, a total of 2,495 foreign corporations were licensed in Wisconsin, a 77% increase from 1,408 in 1990. Incorporation and licensing fees collected by the state in 2010 totaled \$18.9 million.

²Beginning in April 1985, the state motor fuel tax was indexed (1983 Wisconsin Act 27) to take into account fuel consumption and inflation. By law, the tax increase or decrease is automatically calculated annually, based on the inflation rate from the National Highway Maintenance and Operations Cost Index and the percentage change in motor fuel consumption. (The federal gasoline tax has been 18.4 cents per gallon since October 1, 1993.)

³Statutory adjustment (1987 Wisconsin Act 27).

⁴1991 Wisconsin Act 119 postponed further fuel tax indexing until April 1, 1993.

⁵1993 Wisconsin Act 16 set aside the calculation of the consumption factor for 1995 and 1996 and provided fixed consumption factors for each year.

⁶1997 Wisconsin Act 27 increased the motor fuel tax rate and modified the indexing formula to take into account only the change to the cost index.

⁷2005 Wisconsin Act 85 ended annual motor fuel tax indexing as of April 1, 2006.
