

HIGHLIGHTS OF SOCIAL SERVICES IN WISCONSIN

Welfare — According to the U.S. Census Bureau, during 2009-10, almost \$457 billion was spent nationally by state and local governments on a variety of public welfare programs. Wisconsin spent about \$9.5 billion, or \$1,670 per capita, which ranked it 11th among the states, compared to the national average of \$1,476. New York's per capita expenditure was highest at \$2,526 and Nevada the lowest at \$811. Minnesota (\$2,215) was 4th. State and local welfare expenditures represented \$43.94 per \$1,000 of personal income in Wisconsin, ranking it 15th among the states, above the national average (\$37.11), while New Mexico (\$66.02), Maine (\$60.23), Alaska (\$56.66), and Vermont (\$56.54) ranked highest, with Wisconsin's neighbor Minnesota (\$52.08) ranking 6th. Colorado (\$20.00), Nevada (\$22.68), and Virginia (\$27.00) were the lowest.

Participation in Wisconsin Works (W-2), a program providing job subsidies to employers and cash and noncash benefits, such as job assistance and subsidized child care, to participants if they meet certain work requirements, has increased since the last decade but average payments have fallen. The average monthly caseload for W-2 was 15,350 households in 2011 and 14,156 in 2012, with a statewide average monthly payment of \$518 in 2011 and \$510 in 2012. Total W-2 expenditures fell from \$157.2 million in 2011 to \$146.8 million in 2012.

Medical Assistance and BadgerCare — Of the total combined Medical Assistance and BadgerCare provider payments of \$7.00 billion in fiscal year 2011-12, \$2.69 billion (38.5%) was spent on managed care/HMOs. The next highest payment category was \$1.29 billion for other non-institutional fee-for-service (18.4%).

Medical assistance expenditures in Wisconsin in calendar year 2012 rose to \$6.16 billion, from about \$5.41 billion in 2011. A county breakdown of medical assistance for 2012 shows average expenditures of \$3,011 per recipient. According to the Department of Health Services, the counties with the greatest percentage of recipients were Menominee (72.26%), Ashland (58.60%), Milwaukee (56.25%), Rusk (53.80%), and Washburn (53.50%). The counties with the smallest proportion of recipients were Ozaukee (15.76%), Waukesha (16.23%), Pierce (19.43%), and Washington (20.89%). The highest average expenditures per recipient were in Richland (\$5,327), Pepin (\$5,004), Waupaca (\$4,731), and Pierce (\$3,891) counties; Lafayette (\$2,172), Burnett (\$2,209), Vilas (\$2,308), and Taylor (\$2,349) counties were lowest.

Institutions — Since 2010, the average daily adult corrections population declined slightly from 22,643 in 2010 to 22,154 in 2011, and 21,911 in 2012. In 2012, a daily average of 47,178 persons were on probation and 20,593 on parole and mandatory release. Overall, more than 90,000 people were under the control of the Department of Corrections.

A per inmate state expenditure for corrections of \$52,833 ranked Wisconsin 15th among the states in FY2011. As of December 31, 2011, Wisconsin had an incarceration rate of 372 persons per 100,000 population, not counting prisoners under local jurisdiction. Louisiana (865), Mississippi (687), Alabama (646), Oklahoma (640), Texas (639), Arizona (592), Georgia (553), Arkansas (548), and Florida (544) had the highest rates. Maine (147), Massachusetts (154), Minnesota (183), Rhode Island (197), New Hampshire (204), North Dakota (213), Utah (243), Nebraska (244), Vermont (259), Washington (264), New Jersey (277), Hawaii (285), and New York (287), had the lowest rates.

The total average daily number of persons in Wisconsin's care and treatment facilities declined from 1,622 in 2010 to 1,566 in 2011 and 2012.

The number of youths in the state's juvenile corrections institutions declined from 437 in 2010 to 321 in 2011 and to 287 in 2012.
