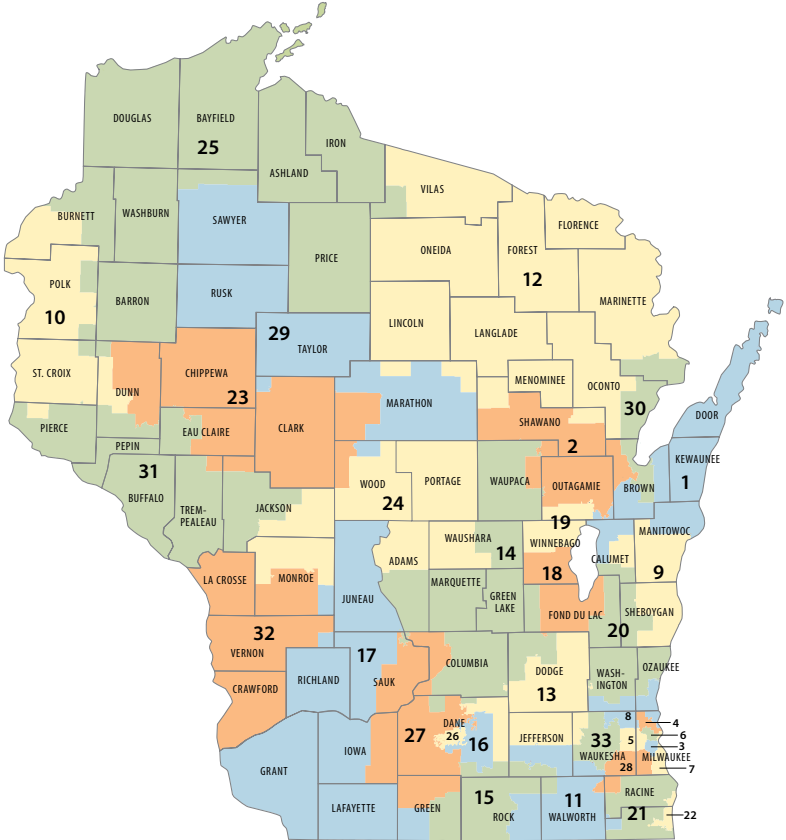

## State Senate Districts

The Wisconsin Constitution requires the state legislature to redraw the state assembly and senate districts, based on population, following each U.S. Census. To fulfill this requirement, the state legislature passed 2011 Wisconsin Act 43 to establish the current senate districts. The Wisconsin Constitution additionally requires that senate districts be “convenient contiguous territory” and that “no assembly district [be] divided in the formation of a senate district.” Under 2011 Wisconsin Act 43, each senate district comprises three consecutive assembly districts: for example, Senate District 1 is comprised of Assembly Districts 1, 2, and 3.
