## I. <u>Department of Public Instruction</u> – Thomas McCarthy, Deputy State Superintendent

The Department of Public Instruction requests a supplement of \$111,000 GPR in fiscal year 2023-24 and \$225,400 GPR in fiscal year 2024-25 from the Committee's appropriation under s. 20.865(4)(a) to the department's general program operations appropriation under s. 20.255(1)(a) and the creation of 1.0 FTE GPR position in unclassified service for the director of the Office of Literacy. The supplement will support the cost of the position and the payment of annual stipends to members of the Council on Early Literacy Curricula created in 2023 Wisconsin Act 20.

## II. Office of the Commissioner of Insurance – Nathan Houdek, Commissioner

The Office of the Commissioner of Insurance requested approval of the creation of 6.07 FTE PR permanent positions beginning in fiscal year 2023-24 and a supplement of \$338,600 PR in fiscal year 2023-24 and \$677,100 PR in fiscal year 2024-25 on an ongoing basis in its general program operations appropriation under s. 20.145(1)(g) under the 14-day passive review of s. 16.505(2) and 16.515. The positions would support administrative functions within the Division of Market Regulation, Division of Financial Regulation, Legal Unit and Office of Operational Management.
